



# Boat Flooring Australia Warranty Policy

Boat Flooring Australia (BFA) hereby warrants to the original purchaser(s) of prefabricated SeaDek product(s) (the "Covered Product"), that for a period of thirty-six (36) months from the date of shipment for delivery by BFA, the Covered Product, under normal use and service conditions, and installed in accordance with BFA's installation and maintenance instructions, shall be free from defects in workmanship and materials.

This warranty includes an additional one-year installation warranty, covering the installation services rendered by Boat Flooring Australia.

This warranty is limited to the replacement of the Covered Product if, in the sole discretion of BFA, the Covered Product fails to perform its intended function as described above, due solely to the Covered Defects listed below. The warranty provided by this form will not extend to any other subsequent purchasers.

## **Exclusion of Light Amplification:**

This warranty explicitly excludes coverage for damages caused by light amplification onto the Covered Product originating from external sources such as boats or surfaces. Light amplification refers to any process or effect that intensifies or increases the brightness of light that falls on the Covered Product due to external factors beyond the control of Boat Flooring Australia.

## **Explanation of Light Amplification:**

Light amplification, in the context of this warranty, pertains to any phenomenon where external light sources, such as powerful spotlights, direct sunlight, or reflective surfaces, cause an increase in the intensity of light that comes into contact with the Covered Product. This includes any light-related damage that arises from prolonged exposure to intense light or heat, resulting in discoloration, fading, or material degradation.

## **COVERAGE:**

Covered Defects:

- Pits
- Delamination
- Damages during packaging
- Production Errors
- CAD Errors
- Logistics Errors
- Excessive Fading
- Material Degradation
- Color Variances
- Color Bleeding

## **INSTALLATION WARRANTY:**

BFA warrants that its installation of the Covered Product shall be free from any defects in workmanship for a period of one (1) year from the date of installation. In the event that a defect or issue arises with respect to the quality or workmanship of the installation within one year of the installation, BFA shall repair or replace the defective installation service.

This warranty applies only to the flooring installation service rendered by Boat Flooring Australia and shall not extend to the workmanship or installation services of any other authorized third-party contractors.

## **LIMITATIONS:**

- This warranty does not apply to any damages caused by neglect, misuse, alterations, neglect, inappropriate use, or improper maintenance.
- This warranty is exclusive, and there are no other representations or warranties, expressed or implied, or any promises, that arise by operation of law or otherwise.

## **CLAIMS:**

Any claims of defect or other covered issues related to the Covered Product and/or workmanship utilized in the installation of the product should be made in writing within thirty (30) days of discovery of such claim. The written claim should include a detailed description and documentation of the issue, evidence of the installation date, and proof of purchase.



# Boat Flooring Australia Warranty Policy

If BFA determines that the Covered Product or installation services provided were defective under the terms of this warranty, BFA will repair or replace the defective component at our sole discretion. Replacement of the defective product shall be BFA's sole obligation under this warranty policy.

This warranty may not be modified, altered, or amended, except by a written instrument executed by BFA and the Buyer. This warranty shall be binding upon and insure to the benefit of the parties hereto. All rights not expressly granted above are reserved to BFA.
